### **Comments**

- HDFC Mutual Fund owns 7.1% of the company. Most of it bought in last 1 year.
- Promoters bought 2.18 lakh shares in the last guarter.
- The buying was done for 4 sessions from 26th March to 21st March.
- Total Delivery Volumes on NSE = 4.72 lakh shares. Promoters bought = 2.18 lakh shares. Almost 50% of the delivery volumes was by promoters. Average price 135.
- Stock closed at 90 on 25th March and 155 on 31st March. All it took was a couple of lakh shares to take the prices up by 50-70%.
- The company has cash of almost 800-1200 crores against a market cap of 1000-1100 cr. The US Business continues to be loss making.
