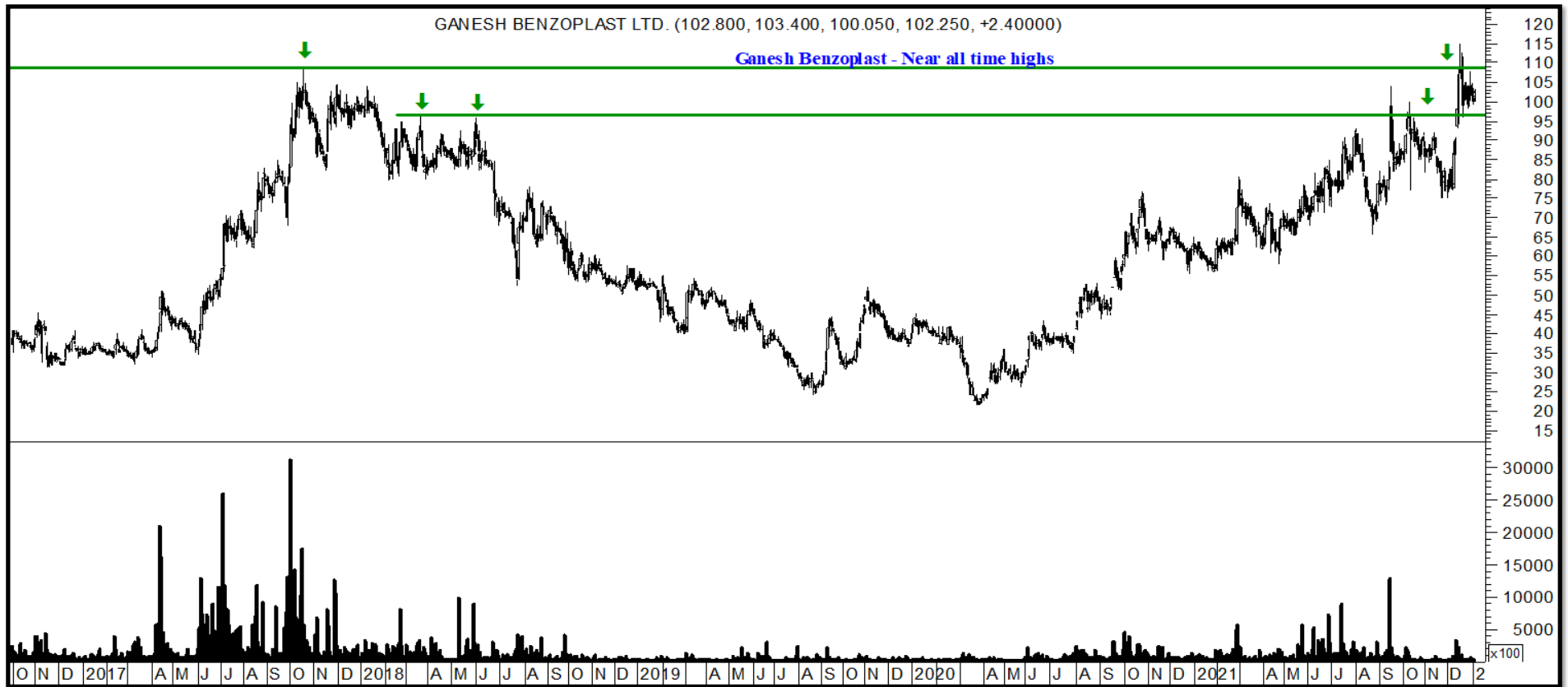

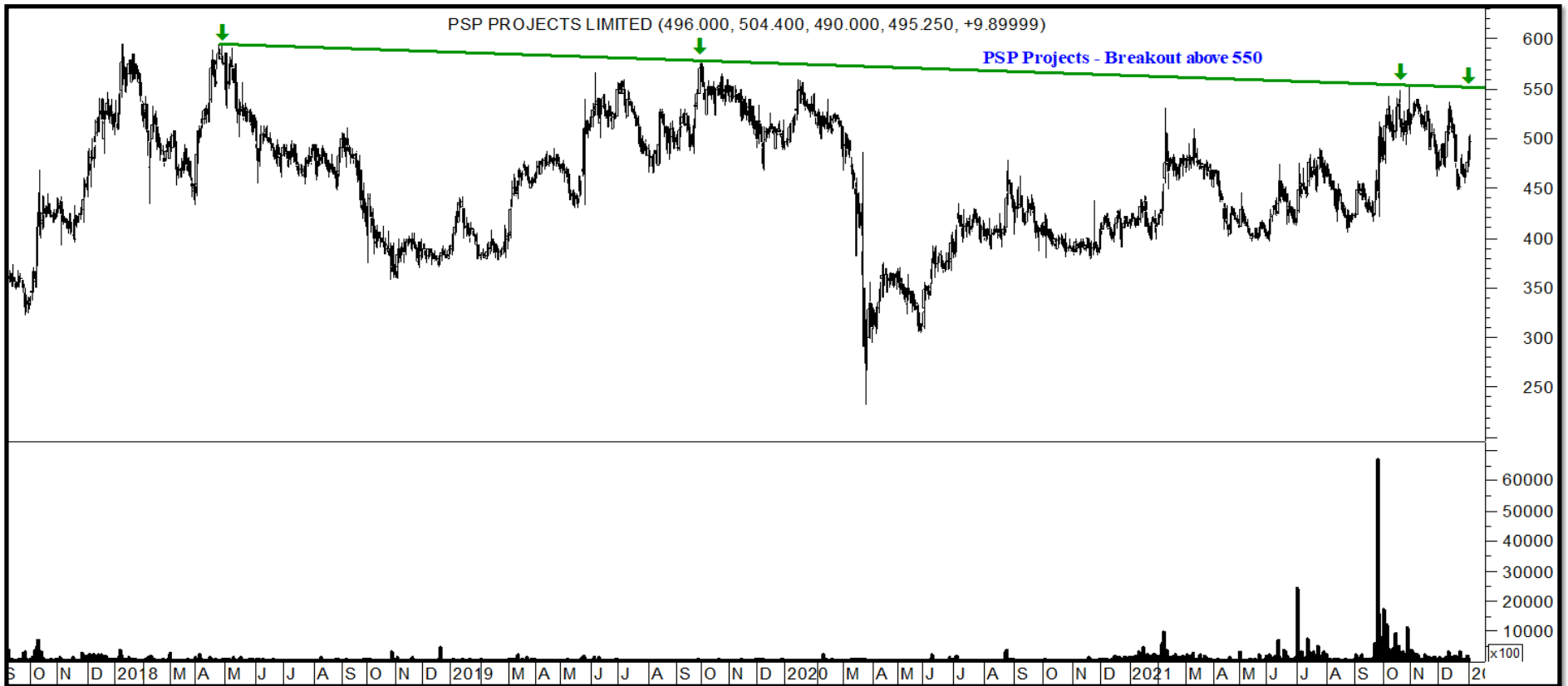

Interesting Chart - GANESH BENZOPLAST LTD.



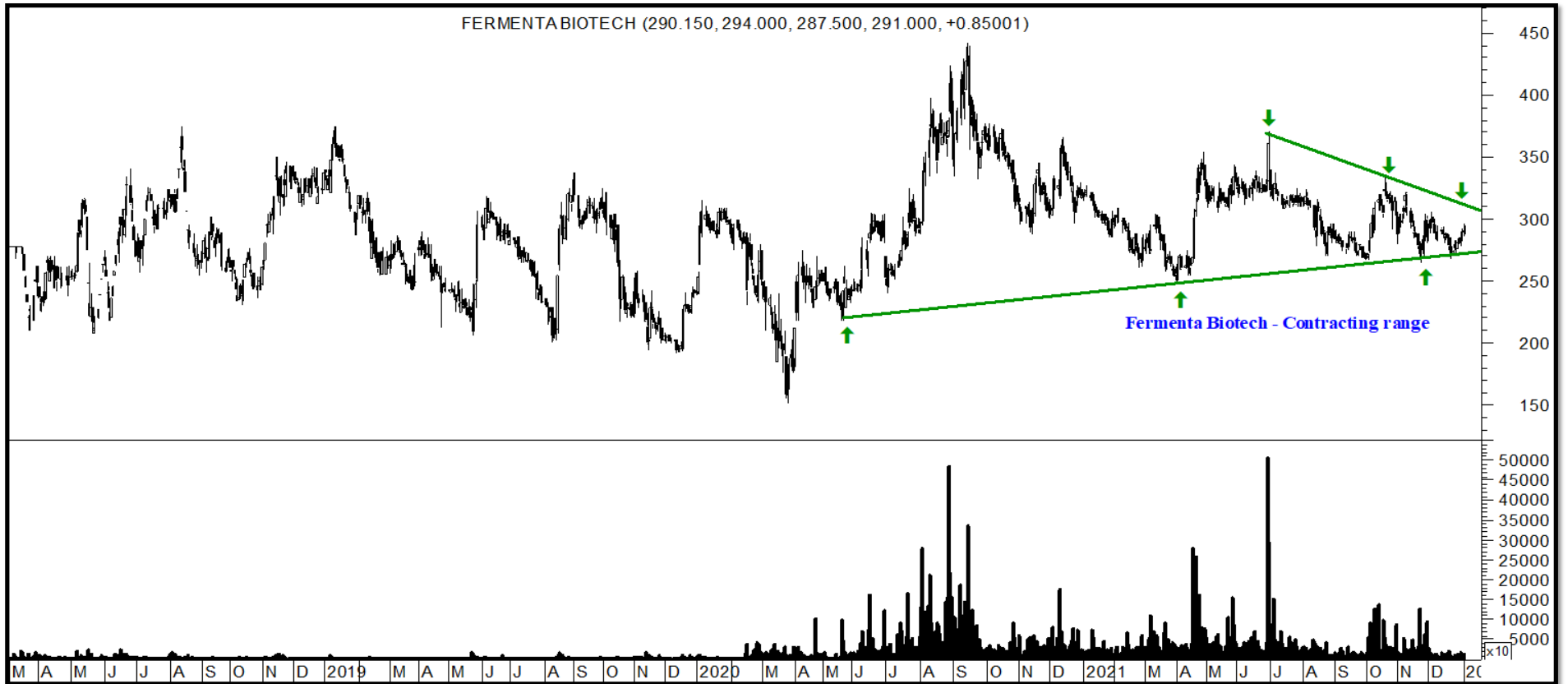

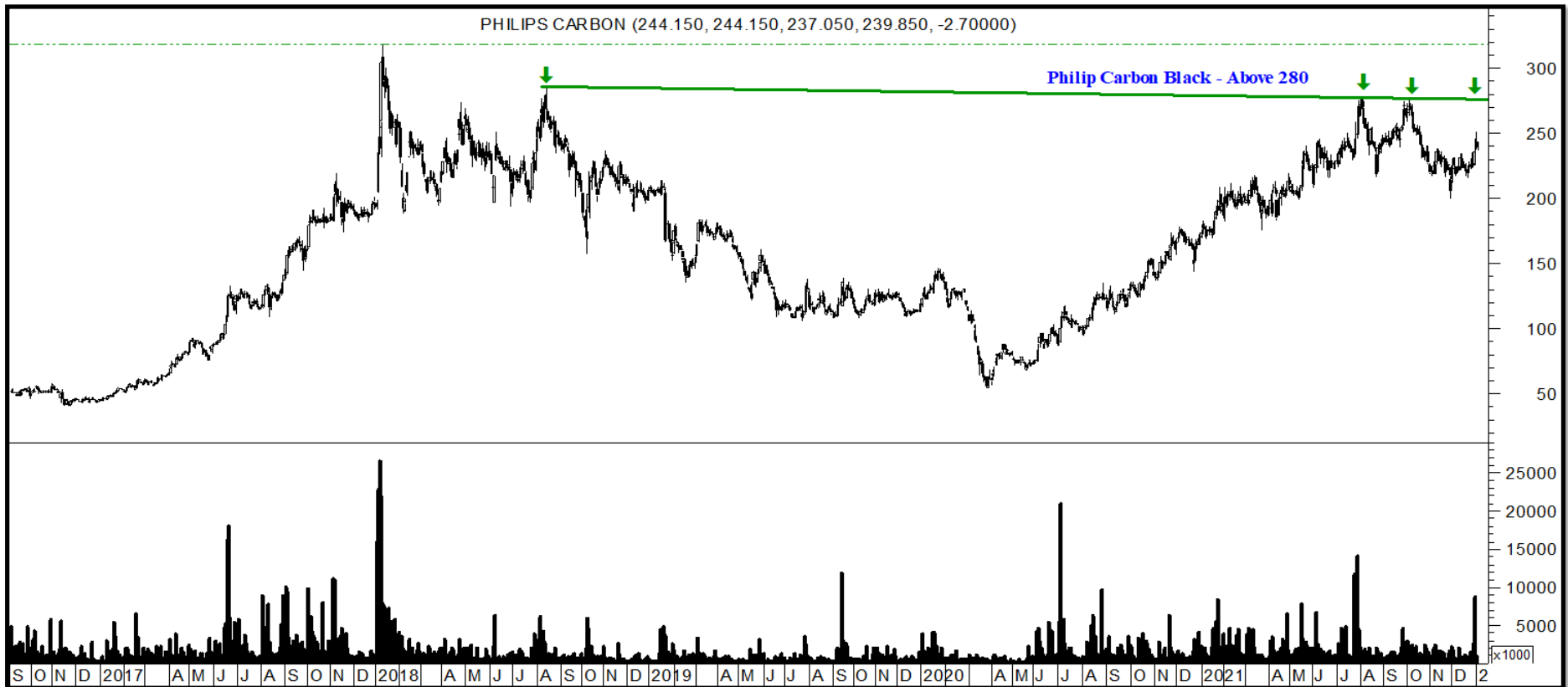

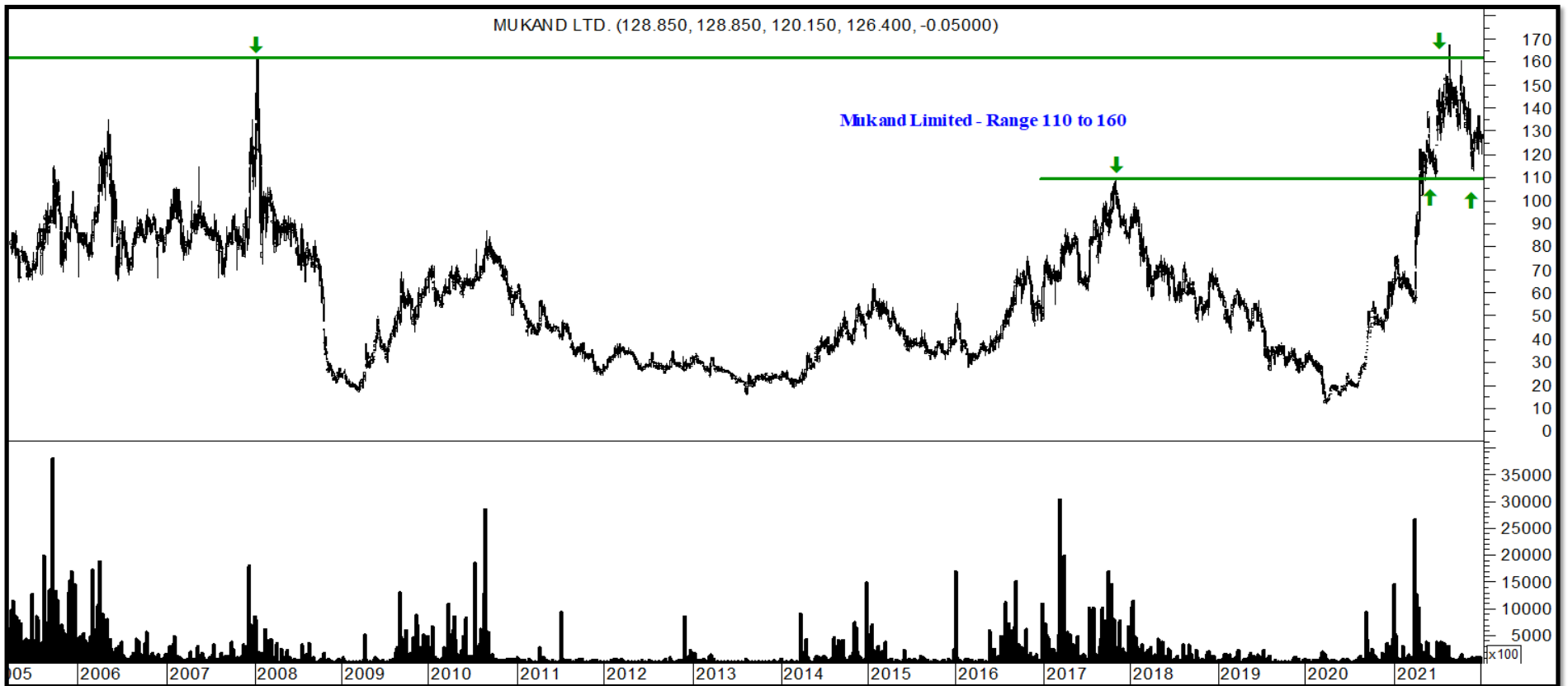

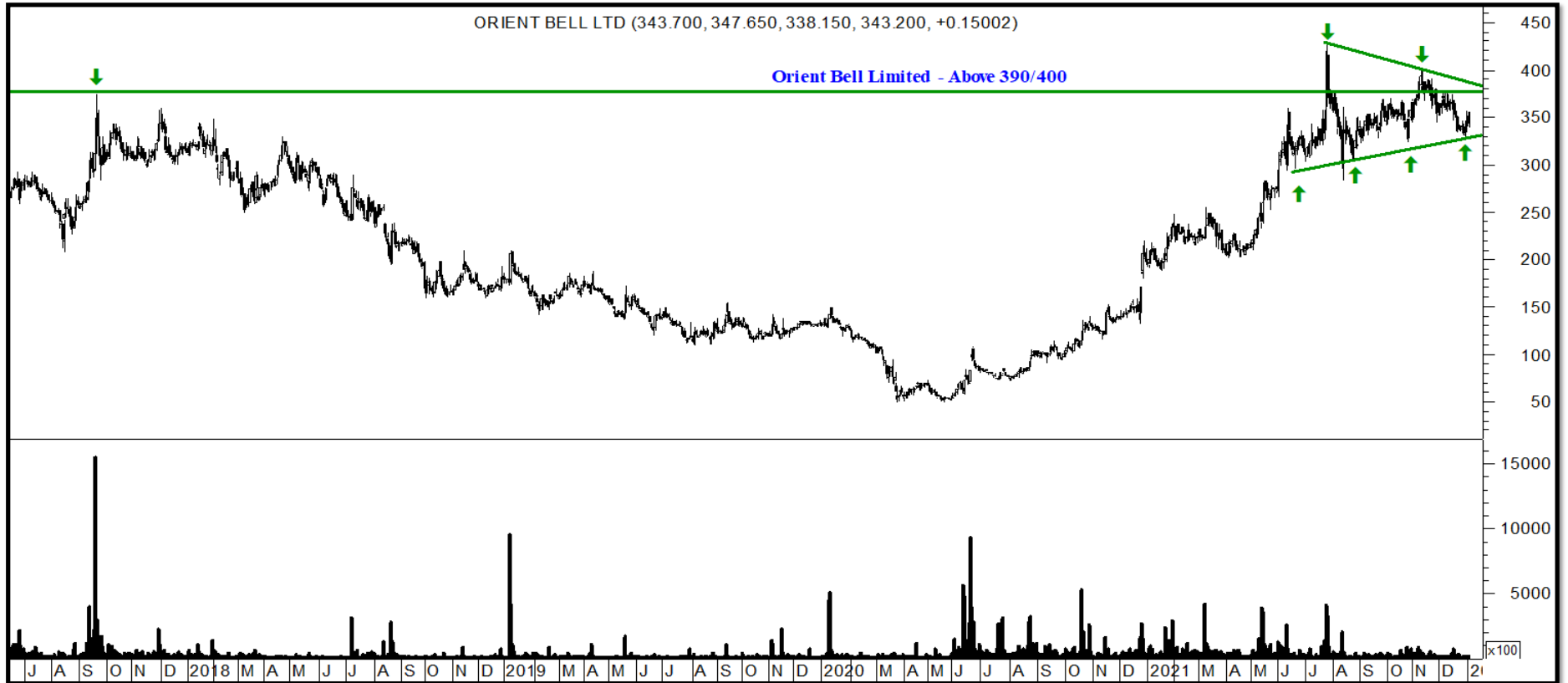
